
#### LOCATION MAP FULTON COUNTY COURTHOUSE COMPLEX

#### Composition of Complex

#### The Fulton County Court Complex is comprised of three buildings:

- LEWIS R. SLATON COURTHOUSE (a/k/a "Fulton County Courthouse" or "Old Courthouse")
- **JUSTICE CENTER TOWER** (a/k/a "New Tower")
- CHARLES L. CARNES BUILDING (a/k/a Justice Center Building)
- ❖ The three buildings are connected via bridges, hallways, an escalator and elevators. Please see attached maps and notes below for more information about how to move from one building to another.

#### Entrances

- You may enter the Complex through entrances on both PRYOR STREET and CENTRAL AVENUE:
  - o The Pryor Street entrance is located at 136 Pryor Street (Lewis R. Slaton Courthouse) on the 1<sup>st</sup> Floor.
    - Lewis R. Slaton Courthouse elevators are located directly ahead of the security area.
  - o The Central Avenue entrance is located at 185 Central Avenue (Justice Center Tower) on the Ground Floor.
    - Justice Center Tower elevators are located to the left of the security area.
    - Lewis R. Slaton Courthouse elevators are located to down the hallway and to the right of the security area.
- You are required to CLEAR SECURITY at each entrance.
  - O You may not bring cameras, tape recorders, sharp objects, glass or weapons with you into the courthouse.
    - Unauthorized items will be confiscated and held by the Sheriff's Department
- You MAY NOT ENTER the complex through the Charles L. Carnes Building. The PRYOR STREET entrance of the building is reserved for employees of the Fulton County Sheriff's Department.

#### Elevators

- Lewis R. Slaton Courthouse-Enter on Pryor Street
  - o The elevators are located directly behind the security area located on the 1<sup>st</sup> Floor.
- Justice Center Tower-Enter on Pryor Street
  - o The elevators are located to the left of the security area located on the Ground Floor.

- ❖ Lewis R. Slaton Courthouse 2<sup>nd</sup> Floor ←HALLWAY→ Justice Center Tower 2<sup>nd</sup> Floor
- ❖ Ground Floor of Justice Center Tower ← HALLWAY/ATRIUM → Ground Floor of Lewis R. Slaton Courthouse
- ♣ Lewis R. Slaton Courthouse 2<sup>nd</sup> Floor ←BRIDGE→ Carnes Justice Building 2<sup>nd</sup> Floor
- Lewis R. Slaton Courthouse 7<sup>th</sup> Floor ←BRIDGE→Justice Center Tower 7<sup>th</sup> Floor
   Lewis R. Slaton Courthouse 8<sup>th</sup> Floor ←BRIDGE→ Justice Center Tower 8<sup>th</sup> Floor
- ❖ Ground Floor of Justice Center Tower ←ESCALATOR→Justice Center Tower 1<sup>st</sup> Floor & Lewis R. Slaton Courthouse 1<sup>st</sup> Floor

## Frequently Visited Locations

## Family Law Clerk's Office (8<sup>th</sup> Floor, Lewis R. Slaton Courthouse)

- ❖ Enter the Lewis R. Slaton Courthouse from the Pryor Street entrance
- ❖ Take the elevators directly behind the security area to the 8<sup>th</sup> Floor
- ❖ Follow signs to the Family Law Clerk's Office (outside of Courtroom 8G)

#### **Judge Cannon's Courtroom (8G, Lewis R. Slaton Courthouse)**

- ❖ Enter the Lewis R. Slaton Courthouse from the Pryor Street entrance
- ❖ Take the elevators directly behind the security area to the 8<sup>th</sup> Floor
- Follow signs to Courtroom 8G

## **Judge Hicks' Courtroom (4C, Justice Center Tower)**

- ❖ Enter JCC through the Central Avenue entrance
- ❖ Take elevators to your left up to the 4<sup>th</sup> Floor and make a left
- \* Courtroom 4C is the first courtroom on your right.

#### **District Attorney's Office**

- ❖ Enter the JCC through the Pryor Street entrance
- ❖ Take the elevators directly in front of you to the 3<sup>rd</sup> Floor, where you will see the receptionist desk.


#### **Superior Court Clerk**

- o Civil Division (1<sup>st</sup> Floor, Lewis R. Slaton Courthouse)
  - ❖ Enter FCC through the Pryor Street entrance
  - ❖ Make a right after clearing security
  - ❖ The Clerk's Office is the first door on the right, before you reach the railing for the atrium overlooking the art exhibit below.
- o Criminal Division (5<sup>th</sup> Floor, Lewis R. Slaton Courthouse)
  - ❖ Enter FCC through the Pryor Street entrance
  - ❖ Take the elevators directly in front of you to the 5<sup>th</sup> Floor.
  - ❖ The information desk is located beyond the double doors
  - ❖ Filing windows are located to the left of the information desk
- o Closed Files (1<sup>st</sup> Floor, Lewis R. Slaton Courthouse)

- ❖ Enter FCC through the Pryor Street entrance
- ❖ Make a left after clearing security
- ❖ Go through double doors and follow signed to Closed Files room.
- \* Request forms are available at the reception desk
- State Court Clerk, Criminal Division (Room J150, Carnes Justice Building)
  - ❖ Enter FCC through Pryor Street entrance and take elevators behind security to 2<sup>nd</sup> Floor
  - ❖ Follow the glass rail until it ends and turn left
  - ❖ Take short ramp to elevator
  - ❖ Take elevator down to 1<sup>st</sup> Floor
  - ❖ Follow signs to State Court Criminal Division, Room J150
- Law Library & Family Law Information Center (7<sup>th</sup> Floor, Justice Center Tower)
  - ❖ Enter FCC through Central Avenue entrance
  - ❖ Take elevators Justice Center Tower elevators, located to your left to 7<sup>th</sup> Floor
