## **PROFESSOR ANTHONY V. ALFIERI**

## ABRIDGED CURRICULUM VITA

Anthony V. Alfieri ("Tony"), Professor of Law and Director, Center for Ethics and Public Service at the University of Miami School of Law, earned an A.B. Law and Society from Brown University graduating Magna Cum Laude in 1981 with concentration and senior thesis honors from the Center for Law and Liberal Education, and a J.D. from Columbia University School of Law graduating in 1984 with Harlan Fiske Stone Scholar and Jane Marks Murphy Prize honors.

From 1984 to 1987, Professor Alfieri served as a staff attorney in the South Bronx Trial Office of the Civil Division of the New York Legal Aid Society specializing in federal and state complex litigation of public benefits entitlements. In 1987, New York Law School appointed him Clinical Associate Professor of Law and Managing Attorney of its Federal Litigation Clinic. In 1990, Marquette University Law School appointed him Assistant Professor of Law and Director of Clinical Studies.

In 1991, Professor Alfieri joined the University of Miami School of Law where he teaches civil procedure and professional responsibility and directs the Law School's Center for Ethics & Public Service. Under his direction, the Center for Ethics & Public Service has won the American Bar Association 1998 E. Smythe Gambrell Professionalism Award, the Florida Bar Seventh Annual 1999-2000 Professionalism Award, and the Miami-Dade County Commission on Ethics and Public Trust 2001 ARETE Award for nonprofit of the year.

Professor Alfieri is a current member of the American Law Institute, a past member of the Florida Bar Standing Committee on Professionalism, a member of the University of Miami Circle of Omicron Delta Kappa Honor Society, and a Contributing Op-Ed Columnist for The Miami Herald. He was the recipient of the 2000 Richard Hausler Professor of the Year Award and the Class of 2000 Amicus Curiae Dedication, and the winner of the Florida Supreme Court 1999 Faculty Professionalism Award.

Professor Alfieri has published twenty-seven articles and essays on ethics, criminal justice, poverty law, and the legal profession in leading journals including Harvard, Yale, Michigan, Cornell, Georgetown, California, Duke, Texas, Columbia, and Stanford. His work is anthologized in LAW STORIES (Gary Bellow & Martha Minow eds., 1996), CLINICAL ANTHOLOGY: READINGS FOR LIVE-CLIENT CLINICS (1997), and CRITICAL RACE THEORY: THE CUTTING EDGE (2d ed., 1999). He and his work have been cited more than 500 times in law journals and in the media.

Professor Alfieri is a member of the American Law Institute and the Florida Bar Standing Committee on Professionalism, the recipient of the 2000 Richard Hausler Professor of the Year Award and the Class of 2000 Amicus Curiae Dedication, and the winner of the Florida Supreme Court 1999 Faculty Professionalism Award.
